NOTIFICATION Imphal, the 15th September, 2025

No. PCB/567/2024-25: In supersession of all previous office orders, memoranda, notifications, etc. issued in this regard, the following procedures shall be followed as an interim arrangement to ensure the timely disposal of *Consent to Establish* and *Consent to Operate* applications by the Manipur Pollution Control Board:

A. Self-certification for Consent to Establish and Consent to Operate

Self-certification for *Consent to Establish* and *Consent to Operate* shall be considered for the *Green* category of industries/units with capital investment up to ₹ 1 crore. Self-certification for *Consent to Establish* only shall be considered for the *Orange* category of industries/units with capital investment up to ₹ 1 crore. The project proponent shall apply for the Consent through the prescribed 'Application Form' with the applicable fees and necessary documents, along with the self-certification in the prescribed format (Annexure-I)

B. <u>Third-party Certification/Audit Report for Consent to Establish and Consent to Operate</u> Third-party Certification/ Audit Report for *Consent to Establish* and *Consent to Operate* shall be considered for all categories of industries/units, irrespective of the capital investments. The project proponents shall apply for the Consent through the Application Form with the applicable fees, necessary documents, self-certification and third-party certification/Audit report. The procedure for empaneling the certified agencies for third-party certification is at Annexure-II.

C. Auto-renewal of Consent to Establish

Auto Renewal of *Consent to Establish* certificate for a further maximum period of 2 (two) years validity period is hereby introduced for all categories of industries/units on application by the project proponent along with the relevant self-certification as applicable, relevant third-party certification/ Audit report accompanied with the applicable fees and the to be renewed *Consent to Establish* certificate.

D. Auto-renewal of Consent to Operate

Auto-renewal of *Consent to Operate* certificate (CTO) for all categories of industries/units is hereby introduced on application by the project proponent through the prescribed Form with the necessary documents, applicable fees, and relevant self-certification and/or third-party certification, as applicable.

Note: In the case of Closure Order/Pending*cases before any Court, Tribunal or Appellate Authority, Auto-Renewal of Consent to Establish/ Consent to Operate will not be applicable.

- viii. That, I/we have understood that for any wrong, partial, forged information/documents submitted by me or any false affirmation made by the undersigned, I shall be liable for legal action including the prosecution under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 and information Technology Act, 2002 along with the provisions of Bharatiya Nyaya Sanhita (BNS).

Annexure-II

Procedures/Guidelines for Third Party Certification/Audit Report

The empaneled Third-Party Certification/Audit Report is hereby accepted for all Categories of Industries for both the *Consent to Establish* Certificate and *Consent to Operate* Certificate. The procedures/guidelines for empaneling the agencies/institutions/environmental auditors for Third Party Certification are as follows:

- i. MPCB will invite expressions of interest for empaneling the list of agencies/institutions/environmental auditors for Third Party Inspection/Certification.
- ii. MPCB will constitute a Technical Expert Committee for framing the eligibility criteria of the agencies/institutions/environmental auditors and also to evaluate the Expression of Interest for empanelment of the agencies/institutions/environmental auditors for Third Party Inspection/ Certification.
- iii. MPCB will empanel the list of agencies/institutions/environmental auditors for Third Party Inspection/Certification.
- iv. The empaneled agencies/institutions/environmental auditors will be entrusted to inspect the projects/industries to check the compliance of terms and conditions of Consent to Establish Certificate and Consent to Operate Certificate, Environment Clearance (if applicable) & air monitoring/ stack monitoring, other environmental parameters as notified from time to time.
- v. The empaneled agencies/institution/environmental auditors shall not inspect the industries if there is a public complaint, legal case, or if, in the opinion of the Board, it does not merit exemption from the inspection of the Board. In these cases, normal inspections will be made by the Board.
- vi. The Project Proponent/ Industry shall bear the expenses incurred towards inspection and monitoring by the empaneled agencies/institutions/environmental auditors for third-party inspection/certification.
- vii. Environmental Laboratories accredited by the National Accreditation Board for Testing and Calibration Laboratories (NABL) and Environmental Impact Assessment (EIA) agencies accredited by the National Accreditation Board for Education & Training (NABET)automatically qualify for third-party certification/audit reports.
